Re: Freedom of Information Act Request

Dear Freedom of Information Officer:

Pursuant to the Freedom of Information Act (FOIA), 5 U.S.C. § 552, and the implementing regulations of the Department of State (State), 22 C.F.R. Part 171, American Oversight makes the following request for records.

The calendars of former United States Mission to the United Nations (USUN) Ambassador Nikki Haley reflect eight calls with former National Security Advisor Michael Flynn. Press reporting suggested that the Trump administration's push in December 2016 to scuttle a United Nations resolution criticizing Israel involved Flynn and Haley.

American Oversight seeks records with the potential to shed light on the communications between Haley and Flynn during Flynn's three-week tenure as National Security Advisor.

Requested Records

American Oversight requests that State produce the following within twenty business days:

All records reflecting communications (email messages, email attachments, calendar invitations or meetings, handwritten or electronic notes from meetings or calls maintained by Ambassador Haley or an assistant, other records memorializing the content of meetings or calls, or talking points) between former USUN Ambassador Nikki Haley and former

National Security Advisor Michael Flynn (including but not limited to communications with the email address michael.t.flynn@nsc.eop.gov).

American Oversight requests any materials related to the below eight engagements between Haley and Flynn and considers any records related to those engagements to be records reflecting communications between Ambassador Haley and Mr. Flynn. State should not, however, limit its search merely to these eight recorded interactions, as there may be records reflecting additional communications between Ambassador Haley and Mr. Flynn.

- 1. Call between former USUN Ambassador Haley, former Secretary of State Tillerson,³ and General Flynn, on or about January 27, 2017;
- 2. Call between former USUN Ambassador Haley, former Secretary of State Tillerson, and General Flynn, on or about January 30, 2017;
- 3. Call between former USUN Ambassador Haley and General Flynn, on or about January 30, 2017;
- 4. Call between former USUN Ambassador Haley and General Flynn, on or about January 31, 2017;
- 5. Call between former USUN Ambassador Haley and General Flynn, on or about February 1, 2017;
- 6. Call between former USUN Ambassador Haley and General Flynn, on or about February 2, 2017;
- 7. Call between former USUN Ambassador Haley and General Flynn, on or about February 6, 2017;
- 8. Call between former USUN Ambassador Haley, former Secretary of State Tillerson, and General Flynn, on or about February 13, 2017.

Please provide all responsive records from January 20, 2017, through April 1, 2017.

In addition to the records requested above, American Oversight also requests records describing the processing of this request, including records sufficient to identify search terms used and locations and custodians searched and any tracking sheets used to track the processing of this request. If State uses FOIA questionnaires or certifications completed by individual custodians or components to determine whether they possess responsive materials or to describe how they conducted searches, we also request any such records prepared in connection with the processing of this request.

Where, as here, high-ranking officials were participants, State should also search the files of the appropriate assistants to those officials. Therefore, State should search at a minimum the files of former Secretary Tillerson and appropriate assistants in addition to the files of Ambassador Haley.

American Oversight seeks all responsive records regardless of format, medium, or physical characteristics. In conducting your search, please understand the terms "record," "document," and "information" in their broadest sense, to include any written, typed, recorded, graphic, printed, or audio material of any kind. We seek records of any kind, including electronic records, audiotapes, videotapes, and photographs, as well as letters, emails, facsimiles, telephone messages, voice mail messages and transcripts, notes, or minutes of any meetings, telephone conversations or discussions. Our request includes any attachments to these records. No category of material should be omitted from search, collection, and production.

Please search all records regarding agency business. You may not exclude searches of files or emails in the personal custody of your officials, such as personal email accounts. Records of official business conducted using unofficial systems or stored outside of official files are subject to the Federal Records Act and FOIA. It is not adequate to rely on policies and procedures that require officials to move such information to official systems within a certain period of time; American Oversight has a right to records contained in those files even if material has not yet been moved to official systems or if officials have, through negligence or willfulness, failed to meet their obligations.⁵

In addition, please note that in conducting a "reasonable search" as required by law, you must employ the most up-to-date technologies and tools available, in addition to searches by individual custodians likely to have responsive information. Recent technology may have rendered State's prior FOIA practices unreasonable. In light of the government-wide requirements to manage information electronically by the end of 2016, it is no longer reasonable to rely exclusively on custodian-driven searches. Furthermore, agencies that have adopted the National Archives and Records Administration (NARA) Capstone program, or similar policies, now maintain emails in a

form that is reasonably likely to be more complete than individual custodians' files. For example, a custodian may have deleted a responsive email from his or her email program, but State's archiving tools would capture that email under Capstone. Accordingly, American Oversight insists that State use the most up-to-date technologies to search for responsive information and take steps to ensure that the most complete repositories of information are searched. American Oversight is available to work with you to craft appropriate search terms. However, custodian searches are still required; agencies may not have direct access to files stored in .PST files, outside of network drives, in paper format, or in personal email accounts.

Under the FOIA Improvement Act of 2016, agencies must adopt a presumption of disclosure, withholding information "only if . . . disclosure would harm an interest protected by an exemption" or "disclosure is prohibited by law." If it is your position that any portion of the requested records is exempt from disclosure, American Oversight requests that you provide an index of those documents as required under *Vaughn v. Rosen*, 484 F.2d 820 (D.C. Cir. 1973), *cert. denied*, 415 U.S. 977 (1974). As you are aware, a *Vaughn* index must describe each document claimed as exempt with sufficient specificity "to permit a reasoned judgment as to whether the material is actually exempt under FOIA." Moreover, the *Vaughn* index "must describe *each* document or portion thereof withheld, and for *each* withholding it must discuss the consequences of disclosing the sought-after information." Further, "the withholding agency must supply 'a relatively detailed justification, specifically identifying the reasons why a particular exemption is relevant and correlating those claims with the particular part of a withheld document to which they apply." "

In the event some portions of the requested records are properly exempt from disclosure, please disclose any reasonably segregable non-exempt portions of the requested records. If it is your position that a document contains non-exempt segments, but that those non-exempt segments are so dispersed throughout the document as to make segregation impossible, please state what portion of the document is non-exempt, and how the material is dispersed throughout the document. Claims of nonsegregability must be made with the same degree of detail as required for claims of exemptions in a *Vaughn* index. If a request is denied in whole, please state specifically that it is not reasonable to segregate portions of the record for release.

You should institute a preservation hold on information responsive to this request. American Oversight intends to pursue all legal avenues to enforce its right of access under FOIA, including litigation if necessary. Accordingly, State is on notice that litigation is reasonably foreseeable.

To ensure that this request is properly construed, that searches are conducted in an adequate but efficient manner, and that extraneous costs are not incurred, American Oversight welcomes an opportunity to discuss its request with you before you undertake your search or incur search or duplication costs. By working together at the outset, American Oversight and State can decrease the likelihood of costly and time-consuming litigation in the future.

Where possible, please provide responsive material in electronic format by email or in PDF or TIF format on a USB drive. Please send any responsive material being sent by mail to American Oversight, 1030 15th Street NW, Suite B255, Washington, DC 20005. If it will accelerate release of responsive records to American Oversight, please also provide responsive material on a rolling basis.

Fee Waiver Request

In accordance with 5 U.S.C. § 552(a)(4)(A)(iii) and 22 C.F.R. § 171.16(a), American Oversight requests a waiver of fees associated with processing this request for records. First, the subject of this request concerns the operations of the federal government, and the disclosures will likely contribute to a better understanding of relevant government procedures by the general public in a significant way. ¹² Second, the request is primarily and fundamentally for non-commercial purposes. ¹³

Under the public interest requirement, FOIA requesters must satisfy four factors. ¹⁴ American Oversight has met these four factors for the reasons set forth below. The subject matter of the requested records specifically relates to the operations or activities of the government, because it concerns how high-ranking agency personnel are using their official time and whether and to what extent external interests are influencing administration policy decisions. In this case, given Michael Flynn's involvement in requesting that Russia help block a United Nations vote on Israeli settlements during the final days of the Obama administration—and his decision to lie about his engagement with the Russian ambassador—records regarding the United Nations Ambassador's communications with Flynn would contribute significantly to the public understanding important government activities and operations. ¹⁵

Increasing the likelihood that disclosure of these records will contribute significantly to public understanding, American Oversight's objective is to reveal to the public at large any information it

receives related to this FOIA request. American Oversight has the capacity to disseminate this information as it posts all records to its public websites and publishes analyses of its records. In the past, the organization has successfully informed the public of specific government activities and operations. As an example, American Oversight obtained Education Secretary DeVos's calendar entries, which revealed Secretary DeVos's frequent absences from office and the influence of charter schools and for-profit colleges on the Education Department. The *New York Times* and CNN relied on American Oversight's analyses to report on Secretary DeVos's priorities within the Department of Education. Department of Education.

Disclosure will contribute to a greater understanding on the part of the public at large about the actions high-ranking officials in the State Department took with regard to United Nations matters, including, as discussed above, whether these officials engaged with the Russian government in order to block a vote concerning Israeli settlements. The requested records also have the potential to shed light more generally on the nature and extent of communications between the USUN Ambassador and a National Security Advisor who was quickly forced to resign due to his connection to a criminal probe related to Russian interference in U.S. elections, which eventually resulted in a conviction for lying to federal investigators. The subject of this request is a matter of public interest, and the public's understanding of the government's activities would be enhanced through American Oversight's analysis and publication of these records.

American Oversight's request is also primarily and fundamentally for non-commercial purposes. ¹⁹ As a 501(c)(3) nonprofit, American Oversight does not have a commercial purpose and the release of the information requested is not in American Oversight's financial interest. American Oversight's mission is to promote transparency in government, to educate the public about government activities, and to ensure the accountability of government officials. American Oversight uses the information gathered, and its analysis of it, to educate the public through reports, press releases, or other media. American Oversight also makes materials it gathers available on our public website and promotes their availability on social media platforms, such as Facebook and

Twitter.²⁰ American Oversight has demonstrated its commitment to the public disclosure of documents and creation of editorial content. For example, after receiving records regarding an ethics waiver received by a senior DOJ attorney, American Oversight promptly posted the records to its website²¹ and published an analysis of what the records reflected about DOJ's process for ethics waivers.²² As an additional example, American Oversight has a project called "Audit the Wall," where the organization is gathering and analyzing information and commenting on public releases of information related to the administration's proposed construction of a barrier along the U.S.-Mexico border.²³

Accordingly, American Oversight qualifies for a fee waiver.
