**Re: Freedom of Information Act Request**

Dear FOIA Officer:

Pursuant to the Freedom of Information Act (FOIA), 5 U.S.C. § 552, and the implementing regulations of your agency, American Oversight makes the following request for records.

The Discharge Review Boards (DRBs) and Boards for Correction of Military/Naval Records (BCMRs) are responsible for hearing veterans' appeals of less-than-honorable discharges. In recent years, there has been considerable outcry on behalf of veterans who received less-than-honorable discharges because they were not properly screened for Post Traumatic Stress Disorder and other combat injuries,<sup>1</sup> suffered from sexual assault while serving,<sup>2</sup> or were discharged because of their sexuality.<sup>3</sup> DOD is legally obligated to publish BCMRs<sup>4</sup> and DRBs<sup>5</sup> past decisions online, allowing veterans and their advocates

to better fight unjust discharges. Before April 2019, DOD published a limited number of past decisions. In April 2019, the agency removed all decisions from its websites without explanation.<sup>6</sup> Responding to a lawsuit over its removal of the records, DOD has since announced that it will restore past decisions to its websites.<sup>7</sup>

American Oversight submits this request to shed light on why DOD decided to remove board decisions in April 2019 and how it decided which board decisions to publish before April 2019.

### **Requested Records**

American Oversight requests that your office produce the following records within twenty business days:

1. All directives, guidance documents, or orders instructing personnel to remove past decisions by your department's Discharge Review Board (DRB) and Board for Correction of Military/Naval Records (BCMR) from online Reading Rooms.

Please provide all responsive records from January 1, 2019, through May 1, 2019.

2. All directives, guidance documents, or orders instructing personnel not to include certain types, categories, or individual DRB and BCMR decisions on your department's Reading Room.

Please provide all responsive records from January 1, 2016, through April 1, 2019.

3. All training materials and/or guidance documents provided to the personnel responsible for deciding which individual DRB and BCMR decisions should be included on your department's Reading Rooms. At a minimum, an adequate search would include searching for guidance on "liberal consideration" and "Supplemental Guidance to Military Boards for Correction of Military/Naval Records Considering Discharge Upgrade Requests by Veterans Claiming Post Traumatic Stress Disorder."

Please provide all responsive records from January 1, 2016, through January 1, 2020.

American Oversight believes that your agency is best positioned to determine where responsive records may reside. American Oversight requests that at a minimum you search agency officials involved in management of the DRBs and BCMRs of your agency, including relevant officials working in the offices of the Director, Deputy Director, Executive Officer, and the Senior Legal Advisor. While American Oversight does not intend to limit its request to the following offices, we suggest that records are likely to be housed in the following location:

Office of Commandant (CG-133), Discharge Review Board

### **Fee Waiver Request**

In accordance with 5 U.S.C. § 552(a)(4)(A)(iii) and your agency's regulations, American Oversight requests a waiver of fees associated with processing this request for records. The subject of this request concerns the operations of the federal government, and the disclosures will likely contribute to a better understanding of relevant government procedures by the general public in a significant way. Moreover, the request is primarily and fundamentally for non-commercial purposes.

American Oversight requests a waiver of fees because disclosure of the requested information is "in the public interest because it is likely to contribute significantly to public understanding of operations or activities of the government."<sup>8</sup> The public has a significant interest in understanding how veterans' appeals are processed and considered.<sup>9</sup> Records with the potential to shed light on this matter would contribute significantly to public understanding of operations of the federal government, including helping veterans and their advocates to understand why board decisions were removed from public Reading Rooms. American Oversight is committed to transparency and makes the responses agencies provide to FOIA requests publicly available, and the public's understanding of the government's activities would be enhanced through American Oversight's analysis and publication of these records.

This request is primarily and fundamentally for non-commercial purposes.<sup>10</sup> As a 501(c)(3) nonprofit, American Oversight does not have a commercial purpose and the release of the information requested is not in American Oversight's financial interest. American Oversight's mission is to promote transparency in government, to educate the public about government activities, and to ensure the accountability of government officials. American Oversight uses the information gathered, and its analysis of it, to educate the public through reports, press releases, or other media. American Oversight

also makes materials it gathers available on its public website and promotes their availability on social media platforms, such as Facebook and Twitter.<sup>11</sup>

American Oversight has also demonstrated its commitment to the public disclosure of documents and creation of editorial content through numerous substantive analyses posted to its website.<sup>12</sup> Examples reflecting this commitment to the public disclosure of documents and the creation of editorial content include the posting of records related to an ethics waiver received by a senior Department of Justice attorney and an analysis of what those records demonstrated regarding the Department's process for issuing such waivers;<sup>13</sup> posting records received as part of American Oversight's "Audit the Wall" project to gather and analyze information related to the administration's proposed construction of a barrier along the U.S.-Mexico border, and analyses of what those records reveal;<sup>14</sup> posting records regarding potential self-dealing at the Department of Housing & Urban Development and related analysis;<sup>15</sup> posting records and analysis relating to the federal government's efforts to sell nuclear technology to Saudi Arabia;<sup>16</sup> and posting records and analysis regarding the Department of Justice's decision in response to demands from Congress to direct a U.S. Attorney to undertake a wide-ranging review and make recommendations regarding criminal investigations relating to the President's political opponents and allegations of misconduct by the Department of Justice itself and the Federal Bureau of Investigation.<sup>17</sup>

Accordingly, American Oversight qualifies for a fee waiver.

### **Guidance Regarding the Search & Processing of Requested Records**

In connection with its request for records, American Oversight provides the following guidance regarding the scope of the records sought and the search and processing of records:

- Please search all locations and systems likely to have responsive records, regardless of format, medium, or physical characteristics.
- In conducting your search, please understand the terms “record,” “document,” and “information” in their broadest sense, to include any written, typed, recorded, graphic, printed, or audio material of any kind. We seek records of any kind, including electronic records, audiotapes, videotapes, and photographs, as well as letters, emails, facsimiles, telephone messages, voice mail messages, and transcripts, notes, or minutes of any meetings, telephone conversations, or discussions.
- Our request for records includes any attachments to those records or other materials enclosed with those records when they were previously transmitted. To the extent that an email is responsive to our request, our request includes all prior messages sent or received in that email chain, as well as any attachments to the email.
- Please search all relevant records or systems containing records regarding agency business. Do not exclude records regarding agency business contained in files, email accounts, or devices in the personal custody of your officials, such as personal email accounts or text messages. Records of official business conducted using unofficial systems or stored outside of official files are subject to the Federal Records Act and FOIA.<sup>18</sup> It is not adequate to rely on policies and procedures that require officials to move such information to official systems within a certain period of time; American Oversight has a right to records contained in those files even if material has not yet been moved to official systems or if officials have, by intent or through negligence, failed to meet their obligations.<sup>19</sup>
- Please use all tools available to your agency to conduct a complete and efficient search for potentially responsive records. Agencies are subject to government-wide

requirements to manage agency information electronically,<sup>20</sup> and many agencies have adopted the National Archives and Records Administration (NARA) Capstone program, or similar policies. These systems provide options for searching emails and other electronic records in a manner that is reasonably likely to be more complete than just searching individual custodian files. For example, a custodian may have deleted a responsive email from his or her email program, but your agency's archiving tools may capture that email under Capstone. At the same time, custodian searches are still necessary; agencies may not have direct access to files stored in .PST files, outside of network drives, in paper format, or in personal email accounts.

- In the event some portions of the requested records are properly exempt from disclosure, please disclose any reasonably segregable non-exempt portions of the requested records. If a request is denied in whole, please state specifically why it is not reasonable to segregate portions of the record for release.
- Please take appropriate steps to ensure that records responsive to this request are not deleted by the agency before the completion of processing for this request. If records potentially responsive to this request are likely to be located on systems where they are subject to potential deletion, including on a scheduled basis, please take steps to prevent that deletion, including, as appropriate, by instituting a litigation hold on those records.

## **Conclusion**

If you have any questions regarding how to construe this request for records or believe that further discussions regarding search and processing would facilitate a more efficient production of records of interest to American Oversight, please do not hesitate to contact American Oversight to discuss this request.
