Re: Open Records Request

Dear Open Records Officer:

Pursuant to the Georgia Open Records Law, as codified at O.C.G.A. §§ 50-18-70 et seq., American Oversight makes the following request for public records.

Requested Records

American Oversight requests that Gwinnett County produce the following within three business days, or provide a written description of any responsive records with a timetable for their production within three business days:

1. All official or unofficial directives, guidance, advisories, or instructions sent by any staff member of the Georgia Secretary of State's Office (including, but not limited to Elections Director Chris Harvey) to Gwinnett County election officials regarding counting and assessing the eligibility of voters who voted by provisional or challenged ballots.

Communications (including emails, email attachments, text messages, calendar invitations/entries, letters, memoranda, or other communications) reflecting such directives, guidance, advisories, or instructions should be considered responsive to this request.

Please provide all responsive records from April 1, 2018, through the date the search is conducted.

2. Records sufficient to identify the number of provisional or challenged ballots cast in Gwinnett County, and the type of each provisional or challenged ballot, as maintained by the county's election office and the county's Provisional/Challenged Ballot Recap form for each election.
3. Records sufficient to identify the number of provisional and challenged ballots approved, withheld, or rejected by the Board of Elections in Gwinnett County.

Please provide all responsive records related to the November 6, 2018 general election; the December 4, 2018 general election runoff; the March 18, 2019 special election; the April 16, 2019 special election runoff; the November 5, 2019 special election; and the December 3, 2019 special election runoff.



Please notify American Oversight of any anticipated fees or costs in excess of \$100 prior to incurring such costs or fees.

American Oversight seeks all responsive records regardless of format, medium, or physical characteristics. In conducting your search, please understand the term “record” in its broadest sense, to include any written, typed, recorded, graphic, printed, or audio material of any kind. We seek records of any kind, including electronic records, audiotapes, videotapes, and photographs, as well as letters, emails, facsimiles, telephone messages, voice mail messages and transcripts, notes, or minutes of any meetings, telephone conversations or discussions. Our request includes any attachments to these records. **No category of material should be omitted from search, collection, and production.**

In addition, American Oversight insists that Gwinnett County use the most up-to-date technologies to search for responsive information and take steps to ensure that the most complete repositories of information are searched. American Oversight is available to work with you to craft appropriate search terms. **However, custodian searches are still required; your office may not have direct access to files stored in .PST files, outside of network drives, in paper format, or in personal email accounts.**

In the event some portions of the requested records are properly exempt from disclosure, please disclose any reasonably segregable non-exempt portions of the requested records. If it is your position that a document contains non-exempt segments, but that those non-exempt segments are so dispersed throughout the document as to make segregation impossible, please state what portion of the document is non-exempt, and how the material is dispersed throughout the document. If a request is denied in whole, please state specifically that it is not reasonable to segregate portions of the record for release.

Please take appropriate steps to ensure that records responsive to this request are not deleted by your office before the completion of processing for this request. If records potentially responsive to this request are likely to be located on systems where they are subject to potential deletion, including on a scheduled basis, please take steps to prevent that deletion, including, as appropriate, by instituting a litigation hold on those records.

To ensure that this request is properly construed, that searches are conducted in an adequate but efficient manner, and that extraneous costs are not incurred, American Oversight welcomes an opportunity to discuss its request with you before you undertake your search or incur search or duplication costs. By working together at the outset, American Oversight and Gwinnett County can decrease the likelihood of costly and time-consuming litigation in the future.

Where possible, please provide responsive material in electronic format by email or in PDF or TIF format on a USB drive. Please send any responsive material being sent by mail to American Oversight, 1030 15th Street NW, Suite B255, Washington, DC 20005. If it will accelerate release of responsive records to American Oversight, please also provide responsive material on a rolling basis.

Conclusion

American Oversight is a 501(c)(3) nonprofit with the mission to promote transparency in government, to educate the public about government activities, and to ensure the accountability of government officials. American Oversight uses the information gathered, and its analysis of it, to educate the public through reports, press releases, or other media. American Oversight also makes materials it gathers
