Re: D.C. Freedom of Information Act Request

Dear FOIA Officer:

Pursuant to the District of Columbia Freedom of Information Act (FOIA), D.C. Code §§ 2-531 et seq., and implementing regulations at 1 DCMR §§ 400 et seq., American Oversight makes the following request for records.

In the days following a police officer killing George Floyd, people in Washington, D.C. have protested against police brutality and white supremacy. Law enforcement has sometimes responded to these protests with violence, including charging at protesters, firing smoke canisters, pepper spray, and rubber bullets.¹

American Oversight requests documents to detail the relationship between the federal government and the Mayor's Office in response to protests.

Requested Records

American Oversight requests that Office of the Mayor produce the following records within fifteen business days:

All email communications (including email messages, complete email chains, email attachments, calendar invitations, and calendar invitation attachments) between (a) Mayor Muriel Bowser, Acting Deputy Mayor and Chief of Staff John Falcicchio, and Senior Advisor Beverly Perry and (b) anyone in the Executive Office of the President (including anyone with an email address ending in eop.gov), National Park Service (@nps.gov), Immigration and Customs Enforcement (@ice.dhs.gov), U.S. Secret Service (@usss.dhs.gov), Department of Justice, including the Drug Enforcement Administration(@usdoj.gov), U.S. Marshals (usmarshals.gov), Bureau of Prisons (@bop.gov), Federal Bureau of Investigation (@fbi.gov), Customs and Border Enforcement (@cbp.dhs.gov), or any representatives of the National Guard or Department of Defense (mail.mil).

Please provide all responsive records from May 26, 2020 to June 8, 2020.

Fee Waiver Request

In accordance with D.C. Code § 2-532(b), American Oversight requests a waiver of fees associated with processing this request for records. A waiver of fees for this request “is in the public interest because furnishing the information can be considered as primarily benefiting the general public.”² The general public has a significant interest in how the D.C. Mayor’s office worked with the federal government when responding to protests against police brutality. During these protests, law enforcement fired smoke canisters, pepper spray, and rubber bullets into protesters and media. Records with the potential to shed light on this issue would contribute significantly to public understanding of operations of both the D.C. and federal government, including understanding Mayor Bowser’s and her senior staff’s awareness of and response to federal law enforcement tactics for protests happening in D.C.

American Oversight is committed to transparency and makes the responses agencies provide to FOIA requests publicly available, and the general public’s understanding of the government’s activities would be enhanced through American Oversight’s analysis and publication of these records. American Oversight’s mission is to promote transparency in government, to educate the public about government activities, and to ensure the accountability of government officials. American Oversight uses the information gathered, and its analysis of it, to educate the public through reports, press releases, or other media. American Oversight also makes materials it gathers available on its public website and promotes their availability on social media platforms, such as Facebook and Twitter.³

American Oversight has also demonstrated its commitment to the public disclosure of documents and creation of editorial content through numerous substantive analyses posted to its website.⁴ Examples reflecting this commitment to the public disclosure of documents and the creation of editorial content include the posting of records related to the organization’s State Accountability Project covering voting rights issues in various states;⁵ the posting of records related to an ethics waiver received by a senior Department of Justice attorney and an analysis of what those records demonstrated regarding the Department’s process for issuing such waivers;⁶ posting records received as part of American Oversight’s “Audit the Wall” project to gather and analyze information related to the administration’s proposed construction of a barrier along the U.S.-Mexico border, and analyses of what those records reveal;⁷ posting records regarding potential self-dealing at the Department of Housing & Urban

Development and related analysis;⁸ posting records and analysis relating to the federal government's efforts to sell nuclear technology to Saudi Arabia;⁹ and posting records and analysis regarding the Department of Justice's decision in response to demands from Congress to direct a U.S. Attorney to undertake a wide-ranging review and make recommendations regarding criminal investigations relating to the President's political opponents and allegations of misconduct by the Department of Justice itself and the Federal Bureau of Investigation.¹⁰

Finally, this request is primarily and fundamentally for non-commercial purposes. As a 501(c)(3) nonprofit, American Oversight does not have a commercial purpose and the release of the information requested is not in American Oversight's financial interest.

Accordingly, furnishing the information sought through this request can be considered as primarily benefiting the general public, and American Oversight thus qualifies for a fee waiver.

Guidance Regarding the Search & Processing of Requested Records

In connection with its request for records, American Oversight provides the following guidance regarding the scope of the records sought and the search and processing of records:

- Please search all locations and systems likely to have responsive records, regardless of format, medium, or physical characteristics. For instance, if the request seeks "communications," please search all locations likely to contain communications.
- In conducting your search, please understand the terms "record," "document," and "information" in their broadest sense, to include any written, typed, recorded, graphic, printed, or audio material of any kind. We seek records of any kind, including electronic records, audiotapes, videotapes, and photographs, as well as letters, emails, facsimiles, telephone messages, voice mail messages and transcripts, notes, or minutes of any meetings, telephone conversations or discussions.
- Our request for records includes any attachments to those records or other materials enclosed with those records when they were previously transmitted. To the extent that an email is responsive to our request, our request includes all prior messages sent or received in that email chain, as well as any attachments to the email.
- Please search all relevant records or systems containing records regarding agency business. Do not exclude records regarding agency business contained in files, email accounts, or devices in the personal custody of your officials, such as personal email accounts or text messages.

If a request is denied in whole, please state specifically why it is not reasonable to segregate portions of the record for release.
- Please take appropriate steps to ensure that records responsive to this request are not deleted by the agency before the completion of processing for this request. If records potentially responsive to this request are likely to be located on systems where they are subject to potential deletion, including on a scheduled basis, please take steps to prevent that deletion, including, as appropriate, by instituting a litigation hold on those records.
