Re: Formal Public Records Act Request

Dear Public Records Officer:

Pursuant to the South Dakota Public Records Act, S.C.D.L. Chapter 1-27, American Oversight makes the following formal, written request for records under S.C.D.L. Section 1-27-37. American Oversight submitted an informal request for the same records on March 1, 2021 (*see* Exhibit 1), but the Office of the Governor did not respond to or acknowledge that request, necessitating this formal request.¹

Requested Records

American Oversight requests that the Office of the Governor produce the following records within ten business days:

Any formal or informal assessment or analysis regarding the impact, including but not limited to cost-savings or benefits, related to Governor Kristi Noem's request for funds to purchase a new executive branch airplane.

Guidance Regarding the Search & Processing of Requested Records

In connection with its request for records, American Oversight provides the following guidance regarding the scope of the records sought and the search and processing of records:

- Please search all locations and systems likely to have responsive records, regardless of format, medium, or physical characteristics.
- Please search all relevant records or systems containing records regarding agency business. Do not exclude records regarding agency business contained in

files, email accounts, or devices in the personal custody of your officials, such as personal email accounts or text messages.

- In the event some portions of the requested records are properly exempt from disclosure, please disclose any reasonably segregable non-exempt portions of the requested records. If a request is denied in whole, please state specifically why it is not reasonable to segregate portions of the record for release.
- Please take appropriate steps to ensure that records responsive to this request are not deleted by the agency before the completion of processing for this request. If records potentially responsive to this request are likely to be located on systems where they are subject to potential deletion, including on a scheduled basis, please take steps to prevent that deletion, including, as appropriate, by instituting a litigation hold on those records.

Re: Informal Public Records Act Request

Dear Records Custodian:

Pursuant to the South Dakota Public Records Act, S.C.D.L. Chapter 1-27, American Oversight makes the following request for records.

Requested Records

American Oversight requests that the Office of the Governor produce the following records as soon as practicable:

Any formal or informal assessment or analysis regarding the impact, including but not limited to cost-savings or benefits, related to Governor Kristi Noem's request for funds to purchase a new executive branch airplane.

Fee Waiver Request

In accordance with S.D.C.L. § 1-27-36, American Oversight requests a waiver of fees associated with processing this request for records. Disclosure of the requested records is in the public interest because it will likely contribute to a better understanding of relevant government procedures by the general public in a significant way. Furthermore, the request is primarily and fundamentally for non-commercial purposes.

American Oversight requests a waiver of fees because disclosure of the requested information is "in the public interest."¹ The public has a significant interest in Governor Noem's request for \$5 million to purchase a new state airplane.² Records with the potential to shed light on this matter would contribute significantly to public understanding of operations of the government, including the potential benefits associated with using \$5 million in taxpayer money to purchase a new airplane. American Oversight is committed to transparency and makes the responses agencies

provide to open records requests publicly available, and the public's understanding of the government's activities would be enhanced through American Oversight's analysis and publication of these records.

This request is primarily and fundamentally for non-commercial purposes. As a 501(c)(3) nonprofit, American Oversight does not have a commercial purpose and the release of the information requested is not in American Oversight's financial interest. American Oversight's mission is to promote transparency in government, to educate the public about government activities, and to ensure the accountability of government officials. American Oversight uses the information gathered, and its analysis of it, to educate the public through reports, press releases, or other media. American Oversight also makes materials it gathers available on its public website and promotes their availability on social media platforms, such as Facebook and Twitter.³

American Oversight has also demonstrated its commitment to the public disclosure of documents and creation of editorial content through regular substantive analyses posted to its website.⁴ Examples reflecting this commitment to the public disclosure of documents and the creation of editorial content include the posting of records and analysis related to the organization's investigations into misconduct and corruption in state governments;⁵ posting records and analysis of federal and state governments' responses to the Coronavirus pandemic;⁶ posting records received as part of American Oversight's "Audit the Wall" project to gather and analyze information related to the

Trump administration's proposed construction of a barrier along the U.S.-Mexico border, and analyses of what those records reveal;⁷ and the posting of records related to an ethics waiver received by a senior U.S. Department of Justice attorney and an analysis of what those records demonstrated regarding the Department's process for issuing such waivers.⁸

Accordingly, American Oversight qualifies for a fee waiver.

- Please take appropriate steps to ensure that records responsive to this request are not deleted by the agency before the completion of processing for this request. If records potentially responsive to this request are likely to be located on systems where they are subject to potential deletion, including on a scheduled basis, please take steps to prevent that deletion, including, as appropriate, by instituting a litigation hold on those records.
