**Re: Public Records Request**

Dear Public Records Officer:

Pursuant to the Arizona Public Records Law, A.R.S. §§ 39-121 et seq., American Oversight makes the following request for records.

In April 2021, Governor Doug Ducey issued a Declaration of Emergency and announced the deployment of the Arizona National Guard to the U.S.-Mexico border.<sup>1</sup> American Oversight seeks records with the potential to shed light on the deployment of National Guard troops.

**Requested Records**

American Oversight requests that your office promptly produce the following records:

1. All email communications (including emails, email attachments, complete email chains, and calendar invitations) sent by Governor Doug Ducey, anyone serving in the capacity of Ducey's Chief of Staff, and/or the senior-most official tasked with coordinating efforts related to the National Guard deployment to the border, regarding the deployment of Arizona National Guard Troops to the U.S.-Mexico border

In an effort to accommodate the Office of the Governor and reduce the number of potentially responsive records to be processed and produced, American Oversight has limited item 1 of its request to emails sent by the specified officials. To be clear, however, American Oversight still requests that complete email chains be produced, displaying both sent and received messages. This means, for example, that both a specified official's response to an email about the National Guard troop deployment and the initial received message are responsive to this request and should be produced.

2. Any memoranda, order, or other document reflecting or outlining the scope of the deployment of Arizona National Guard troops to the U.S.-Mexico border including limits placed on or authorities given to National Guard troops deployed to the border.
3. Any formal or informal assessment or analysis provided to or created by your office regarding the deployment of Arizona National Guard troops to the U.S.-Mexico border, including assessments or analyses regarding the legality of deployment or involving the Emergency Management Assistance Compact.
4. Records reflecting summaries, readouts, or after-action reports for the deployment of Arizona National Guard troops to the U.S.-Mexico border.

The start date for this request is March 1, 2021.

Please consider this a standing request, the response to which should be updated promptly each time new information is added to any responsive records or new responsive records are created. *See W. Valley View, Inc. v. Maricopa Cty. Sheriff's Off.*, 216 Ariz. 225, 228 (App. 2007).

### **Statement of Noncommercial Purpose**

This request is made for noncommercial purposes. American Oversight seeks records regarding the deployment of Arizona National Guard troops to the U.S.-Mexico border. Records with the potential to shed light on this matter would contribute significantly to public understanding of operations of the government, including if a legal analysis was conducted before the troop deployment.

Because American Oversight is a 501(c)(3) nonprofit, this request is not in American Oversight's financial interest and is not made for a commercial purpose. American Oversight's mission is to promote transparency in government, to educate the public about government activities, and to ensure the accountability of government officials. American Oversight uses the information gathered, and its analysis of it, to educate the public through reports, press releases, or other media. American Oversight also makes materials it gathers available on its public website and promotes their availability on social media platforms, such as Facebook and Twitter.<sup>2</sup>

Because this request is made for noncommercial purposes, American Oversight requests that any fees charged in connection with processing this request be limited to copying

and postage charges, if applicable.<sup>3</sup> Please notify American Oversight of any anticipated fees or costs in excess of \$100 prior to incurring such costs or fees.

### **Guidance Regarding the Search & Processing of Requested Records**

In connection with its request for records, American Oversight provides the following guidance regarding the scope of the records sought and the search and processing of records:

- Please search all locations and systems likely to have responsive records, regardless of format, medium, or physical characteristics.
- In conducting your search, please understand the terms “record,” “document,” and “information” in their broadest sense, to include any written, typed, recorded, graphic, printed, or audio material of any kind. We seek records of any kind, including electronic records, audiotapes, videotapes, and photographs, as well as letters, emails, facsimiles, telephone messages, voice mail messages and transcripts, notes, or minutes of any meetings, telephone conversations or discussions.
- Our request for records includes any attachments to those records or other materials enclosed with those records when they were previously transmitted. To the extent that an email is responsive to our request, our request includes all prior messages sent or received in that email chain, as well as any attachments to the email.
- Please search all relevant records or systems containing records regarding agency business. Do not exclude records regarding agency business contained in files, email accounts, or devices in the personal custody of your officials, such as personal email accounts or text messages.
- If any records are withheld in full or in part, pursuant to A.R.S. § 39-121.01(D)(2), please provide an index of records or categories of records that have been withheld and the reasons the records or categories of records have been withheld.
- In the event some portions of the requested records are properly exempt from disclosure, please disclose any reasonably segregable non-exempt portions of the requested records. If a request is denied in whole, please state specifically why it is not reasonable to segregate portions of the record for release.
- Please take appropriate steps to ensure that records responsive to this request are not deleted by the agency before the completion of processing for this

request. If records potentially responsive to this request are likely to be located on systems where they are subject to potential deletion, including on a scheduled basis, please take steps to prevent that deletion, including, as appropriate, by instituting a litigation hold on those records.
