**Re: Public Records Request**

Dear Public Records Officer:

Pursuant to the Arizona Public Records Law, A.R.S. §§ 39-121 et seq., American Oversight makes the following request for records.

**Requested Records**

American Oversight requests that the Arizona Attorney General's Office promptly produce the following records:

1. All email communications (including emails, complete email chains, calendar invitation, and attachments thereto) sent by any of the Attorney General's Office officials listed below concerning changes in the Attorney General's election authorities (including, but not limited to, communications concerning Senate Bill 1819).

At a minimum, communications concerning the following changes would be responsive to this request and should be produced:

- i. The shift of authority related to election-related litigation away from the Secretary of State or the Attorney General's related new authority to represent the state in all election-related litigation and direct the defense of Arizona's election laws
- ii. The requirement that the Secretary of State provide access to the statewide voter registration database to the Attorney General's Election Integrity Unit and a designee of the Arizona Legislature
- iii. The requirement that the Secretary of State post a list of each event at which it offers voter registration services to its website and report to the auditor general a description of all voter registration programs and events as well as related expenditure information

In an effort to accommodate the Attorney General's Office and reduce the number of potentially responsive records to be processed and produced, American Oversight has limited this request item 1 to emails sent by the listed officials. To be clear, however, American Oversight still requests that complete email chains be produced, displaying both sent and received messages. This means, for example, that both Attorney General Brnovich's response to an email concerning the requirement that the Secretary of State provide access to the statewide voter registration database to the Attorney General's Election Integrity Unit and the initial received message are responsive to this request and should be produced.

- 2. All records reflecting any formal or informal directive, order, advisory, guidance, or final analysis regarding the provisions of Senate Bill 1819 referenced in request item 1.

For both items 1 and 2, please provide all responsive records from May 20, 2021, through the date the search is conducted.

### **Statement of Noncommercial Purpose**

This request is made for noncommercial purposes. American Oversight seeks records regarding post-2020 electoral process reforms, which are of great public interest in Arizona.<sup>1</sup> Records with the potential to shed light on this matter would contribute significantly to public understanding of operations of the government, including whether and to what extent state officials have experienced difficulties while implementing new election processes.

Because American Oversight is a 501(c)(3) nonprofit, this request is not in American Oversight's financial interest and is not made for a commercial purpose. American Oversight's mission is to promote transparency in government, to educate the public about government activities, and to ensure the accountability of government officials. American Oversight uses the information gathered, and its analysis of it, to educate the public through reports, press releases, or other media. American Oversight also makes

materials it gathers available on its public website and promotes their availability on social media platforms, such as Facebook and Twitter.<sup>2</sup>

Because this request is made for noncommercial purposes, American Oversight requests that any fees charged in connection with processing this request be limited to copying and postage charges, if applicable.<sup>3</sup> Please notify American Oversight of any anticipated fees or costs in excess of \$100 prior to incurring such costs or fees.

### **Guidance Regarding the Search & Processing of Requested Records**

In connection with its request for records, American Oversight provides the following guidance regarding the scope of the records sought and the search and processing of records:

- Please search all locations and systems likely to have responsive records, regardless of format, medium, or physical characteristics. For instance, if the request seeks “communications,” please search all locations likely to contain communications, including relevant hard-copy files, correspondence files, appropriate locations on hard drives and shared drives, emails, text messages or other direct messaging systems (such as iMessage, WhatsApp, Signal, or Twitter direct messages), voicemail messages, instant messaging systems such as Lync or ICQ, and shared messages systems such as Slack.
- In conducting your search, please understand the terms “record,” “document,” and “information” in their broadest sense, to include any written, typed, recorded, graphic, printed, or audio material of any kind. We seek records of any kind, including electronic records, audiotapes, videotapes, and photographs, as well as letters, emails, facsimiles, telephone messages, voice mail messages and transcripts, notes, or minutes of any meetings, telephone conversations or discussions.
- Our request for records includes any attachments to those records or other materials enclosed with those records when they were previously transmitted. To the extent that an email is responsive to our request, our request includes all prior messages sent or received in that email chain, as well as any attachments to the email.

- Please search all relevant records or systems containing records regarding agency business. Do not exclude records regarding agency business contained in files, email accounts, or devices in the personal custody of your officials, such as personal email accounts or text messages.
- If any records are withheld in full or in part, pursuant to A.R.S. § 39-121.01(D)(2), please provide an index of records or categories of records that have been withheld and the reasons the records or categories of records have been withheld.
- In the event some portions of the requested records are properly exempt from disclosure, please disclose any reasonably segregable non-exempt portions of the requested records. If a request is denied in whole, please state specifically why it is not reasonable to segregate portions of the record for release.
- Please take appropriate steps to ensure that records responsive to this request are not deleted by the agency before the completion of processing for this request. If records potentially responsive to this request are likely to be located on systems where they are subject to potential deletion, including on a scheduled basis, please take steps to prevent that deletion, including, as appropriate, by instituting a litigation hold on those records.
