Re: Freedom of Access Request

Dear Secretary Grant and Senator Stewart:

Pursuant to the Maine Freedom of Access Act, Me. Rev. Stat. tit. 1, §§ 400 et seq., American Oversight makes the following request for records.

Requested Records

American Oversight requests that the Office of Senator Trey Stewart produce the following records within a reasonable period of time:

1. Any handouts, agendas, presentation materials, summaries, or notes (electronic or handwritten) provided to or created by Senator Stewart as part of or in relation to the Honest Elections Project Academy event held between July 26 and July 28, 2021 in Salt Lake City, Utah.¹
2. Any model legislation in Senator Stewart's possession originating from or distributed by the Honest Elections Project.
3. All email communications (including emails, complete email chains, calendar invitations, and attachments thereto) between (a) Senator Stewart, and (b) Jason Snead (including, but not limited to, at jason@jasonsnead.com), Gary Marx (including, but not limited to, at gary@madisonstrategiesllc.com), or anyone communicating on behalf of the Honest Elections Project (including,

but not limited to, anyone communicating from an email address ending in @honestelections.org).

4. All email communications (including emails, complete email chains, calendar invitations, and attachments thereto) between (a) Senator Stewart and (b) anyone communicating on behalf of the American Legislative Exchange Council (ALEC) (including, but not limited to, anyone communicating from an email address ending in @alec.org).
5. All email communications (including emails, complete email chains, calendar invitations, and attachments thereto) sent or received by Senator Stewart containing the terms “Honest Elections Project,” “HEP,” “ALEC,” “Legislative Exchange,” or “Grand America.”

For all parts of this request, please provide all responsive records from May 1, 2021, through September 1, 2021.

Fee Waiver Request

In accordance with Me. Rev. Stat. tit. 1, § 408-A(11)(B), American Oversight requests a waiver of fees associated with processing this request for records. Disclosure of the requested records is in the public interest because it will likely contribute to a better understanding of relevant government procedures by the general public in a significant way. Moreover, the request is primarily and fundamentally for non-commercial purposes.

American Oversight requests a waiver of fees because disclosure of the requested information will contribute significantly to public understanding of the operations of the government.² The public has a significant interest in the influence of Honest Elections Project, a leading advocate for restrictive voting laws, on state legislators.³ Records with the potential to shed light on this matter would contribute significantly to public understanding of operations of the government, including whether and to what extent Maine state legislators have been influence in their official duties by Honest Elections Project. American Oversight is committed to transparency and makes the responses agencies provide to public records requests publicly available, and the public’s understanding of the government’s activities would be enhanced through American Oversight’s analysis and publication of these records.

This request is primarily and fundamentally for non-commercial purposes. As a 501(c)(3) nonprofit, American Oversight does not have a commercial purpose and the release of the information requested is not in American Oversight’s financial interest. American Oversight’s mission is to promote transparency in government, to educate the public about government activities, and to ensure the accountability of government officials. American Oversight uses the information gathered, and its analysis of it, to

educate the public through reports, press releases, or other media. American Oversight also makes materials it gathers available on its public website and promotes their availability on social media platforms, such as Facebook and Twitter.⁴

American Oversight has also demonstrated its commitment to the public disclosure of documents and creation of editorial content through regular substantive analyses posted to its website.⁵ Examples reflecting this commitment to the public disclosure of documents and the creation of editorial content include the posting of records and analysis related to the organization’s investigations into misconduct and corruption in state governments;⁶ posting records and analysis of federal and state governments’ responses to the Coronavirus pandemic;⁷ posting records received as part of American Oversight’s “Audit the Wall” project to gather and analyze information related to the Trump administration’s proposed construction of a barrier along the U.S.-Mexico border, and analyses of what those records reveal;⁸ and the posting of records related to an ethics waiver received by a senior Department of Justice attorney and an analysis of

what those records demonstrated regarding the Department's process for issuing such waivers.⁹

Accordingly, American Oversight qualifies for a fee waiver.

Guidance Regarding the Search & Processing of Requested Records

In connection with its request for records, American Oversight provides the following guidance regarding the scope of the records sought and the search and processing of records:

- Please search all locations and systems likely to have responsive records, regardless of format, medium, or physical characteristics. For instance, if the request seeks “communications,” please search all locations likely to contain communications, including relevant hard-copy files, correspondence files, appropriate locations on hard drives and shared drives, emails, text messages or other direct messaging systems (such as iMessage, WhatsApp, Signal, or Twitter direct messages), voicemail messages, instant messaging systems such as Lync or ICQ, and shared messages systems such as Slack.
- Our request for records includes any attachments to those records or other materials enclosed with those records when they were previously transmitted. To the extent that an email is responsive to our request, our request includes all prior messages sent or received in that email chain, as well as any attachments to the email.
- Please search all relevant records or systems containing records regarding agency business. Do not exclude records regarding agency business contained in files, email accounts, or devices in the personal custody of your officials, such as personal email accounts or text messages.
- In the event some portions of the requested records are properly exempt from disclosure, please disclose any reasonably segregable non-exempt portions of the requested records. If a request is denied in whole, please state specifically why it is not reasonable to segregate portions of the record for release.
- Please take appropriate steps to ensure that records responsive to this request are not deleted by the agency before the completion of processing for this request. If records potentially responsive to this request are likely to be located on systems where they are subject to potential deletion, including on a scheduled

basis, please take steps to prevent that deletion, including, as appropriate, by instituting a litigation hold on those records.
