### Who We Are

American Oversight is a nonpartisan watchdog dedicated to advancing truth, accountability, and democracy by enforcing the public's right to government records. Since our founding in 2017, we have uncovered and published tens of thousands of documents from federal, state, and local agencies, providing critical evidence that has supported congressional investigations, investigative journalism, and independent actions by partner organizations. With a focus on countering attacks on democratic institutions, preventing abuses of power, protecting civil rights, and fighting against the erosion of government transparency, our team of more than 30 lawyers, researchers, and advocates works tirelessly to expose misconduct and hold leaders accountable. Through our online document library, we have shared more than one million pages of records, equipping the public and our partners with the tools needed to shine a light on abuses of power and threats to democracy. Looking ahead, we will continue to challenge unlawful efforts to undermine federal transparency laws, including the Freedom of Information Act (FOIA), and access to public records and to fight the current administration's attempts to evade transparency.

#### Leveraging Public Records for Accountability Since 2017

Our work at the federal, state, and local levels since 2017 has been far-reaching. From exposing abuses of power in the Trump administration to fighting election denialism and combating efforts to weaken public records laws, American Oversight has played a critical role in ensuring transparency remains a tool for justice and accountability. Below are just a few examples of how our public records work has shaped the public's understanding of government misconduct and helped drive meaningful consequences.

#### **Exposing Trump Administration Corruption and Abuse of Power**


In 2019 and early 2020, American Oversight played a critical role in uncovering key evidence during the prior Trump administration, including exposing <u>Rudy Giuliani's communications</u> with then-Secretary of State Mike Pompeo and the White House in the lead-up to the Trumpsanctioned pressure campaign on the Ukrainian government, as well as <u>records confirming</u> that the direction to withhold congressionally approved military aid came from the president. Documents obtained through our lawsuits shed light on attempts to smear then-Ambassador to Ukraine Marie Yovanovitch, which informed public understanding of the corrupt scheme and demonstrated the administration's unprecedented obstruction of congressional oversight. These records were later cited by Congress during Trump's first impeachment. American Oversight also <u>uncovered records</u> that raised significant concerns about the impartiality of the Justice Department under Attorney General William Barr.

#### Fighting Election Denial Through Transparency and Accountability

In 2021, American Oversight <u>obtained copies of phony electoral certificates</u> from seven states — Arizona, Georgia, Michigan, New Mexico, Nevada, Pennsylvania, and Wisconsin — that Trump supporters submitted to Congress as part of the failed attempt to overturn the results of the 2020 election. Revelations about the scheme led to <u>criminal charges</u> in Wisconsin, Nevada, Georgia, and Michigan, and American Oversight has continued to use public records <u>to expose</u> the network of activists and politicians working to undermine trust in our elections and democracy <u>as a way to restrict voting rights</u>.

#### **Combating Efforts to Undermine Public Records Laws and Practices**

In 2022, <u>American Oversight uncovered</u> that the Department of Defense and the Army had wiped the phones of certain former senior Trump administration officials, including former acting Defense Secretary Chris Miller and former Army Secretary Ryan McCarthy, resulting in the loss of any text messages from the day of the January 6 insurrection. Within days, the Pentagon <u>publicly announced</u> a new policy regarding the preservation of text messages and other information stored on mobile devices. The <u>Department of Homeland Security</u> (DHS) also announced it would stop wiping the phones of high-level officials without backing them up, and would launch a review of its record retainment practices. Our work has also exposed failures in record-keeping practices in <u>key states</u>, affirming the public's right to government documents and the importance of record retention laws.



# 2024 American Oversight Impact Highlights

In 2024, we expanded our efforts to combat abuses of power, shore up democratic institutions, and fight for transparency. We worked closely with more than 120 partners at the national, state, and local levels to uncover documents that could inform the American public and support the advocacy of progressive organizations fighting election subversion, abuses of power, and attacks on civil rights and liberties.

#### **Combating Attacks on Election Administration and Voting Rights**

In 2024, American Oversight submitted hundreds of records requests across multiple states regarding election administration and potential election subversion activities. Our documents revealed the vast, coordinated network of individual activists, organizations, and politicians working to undermine election administration and cast doubt on voting security. We closely collaborated with national and state partners to craft targeted requests and share relevant documents, with American Oversight becoming a go-to resource for voting rights advocates and organizations seeking the latest information on nationwide election subversion actors, networks, and activities.

#### In the States

Arizona: Success in Cochise County



In Cochise County, Ariz., American Oversight filed suit in early 2024 after the county delayed for more than a year the release of records related to hand-count procedures. Our lawsuit exposed coordination between County Supervisors Peggy Judd and Tom Crosby — who were both indicted for delaying the certification of the 2022 election results — and members of the Arizona legislature who were involved in election denial and efforts like the sham audit of Maricopa County's 2020 election. When the county admitted to failing to preserve communications during a deposition, we forced them to conduct a forensic audit of their phones, which uncovered critical evidence. Judd and Crosby subsequently invoked the Fifth Amendment during their depositions in our lawsuit, with American Oversight challenging their refusals to testify. The insights gained from our Cochise County litigation, which was settled in late 2024, was a key part of our broader campaign to ensure the preservation of election-related records in states across the country.

#### Fighting for Transparency in Georgia

We worked closely with key partners like All Voting is Local to counter election subversion in Georgia. In the months leading up to the 2024 election, the Georgia State Election Board's (SEB) far-right, Trump-aligned majority — whom Trump referred to as his "pit bulls" — drew scrutiny for its efforts to undermine trust in the vote and avoid public accountability. In July, the three members of that majority held a meeting in violation of Georgia's Open Meetings Act, during which they tried to advance controversial new rules. After we sued, the board withdrew its problematic rules, later reintroducing them during a properly noticed meeting — but one held less than three months before the election. Our timely litigation resulted in subsequent court rulings that found that election rule changes could not be implemented that close to the election. After learning that two of the ultraconservative board members had systematically obstructed requests by using private email accounts for business and refusing to adequately search for or produce records, we filed additional requests and subsequently sued the SEB and one of its members, Janice Johnston, while calling on the Georgia inspector general, attorney general, and other state officials to open an investigation into the SEB's violations of the law.

#### Advancing Accountability in Maryland

In advance of the 2024 election, as part of an effort to undermine the election and purge voters from the rolls, right-wing activists sued numerous states, alleging that their voter rolls were inaccurate and improperly maintained. Maryland was the first state sued by the fringe election denial group United Sovereign Americans. American Oversight submitted requests to the Maryland State Board of Elections for officials' communications and discovered board members had an extensive relationship with the plaintiffs, persisting even after the group had sued. After the records were reported on by the <u>Baltimore Banner</u>, the board <u>changed its bylaws</u> to restrict communications with groups in active litigation against election officials, curbing the influence of election denial activists.

#### Championing Election Administration Improvements in Wisconsin



Wisconsin partners — including All Voting is Local Wisconsin, Common Cause, the League of Women Voters, and the ACLU — raised concerns about the canvass process, emphasizing the need for more information to allocate election protection resources effectively. They also sought a clearer understanding of how public information on canvassing was being handled across states. In response, they called on American Oversight to submit records requests to all 72 counties to obtain critical details about county canvasses, a key step in election certification. To address persistent challenges in tracking this process, the collected data was compiled into a comprehensive database, equipping partners with the ability to anticipate and respond to potential post-election canvass disruptions. As a direct result of this work, the Wisconsin Elections Commission issued clarifying guidance to administrators on posting essential canvass information, ensuring greater transparency and accessibility.

#### **Providing Information and Technical Assistance to Advocates**

- In North Carolina, we supported partner organizations by submitting records requests on
  partisan poll monitors and election judges to help inform on-the-ground election protection.
  We also shared key records and information on election deniers like Jim Womack —
  information that was used by the Southern Coalition for Social Justice in depositions as part of
  the organization's voting rights litigation.
- We met with the ACLU's Voting Rights Project to provide information and documentation on the Election Integrity Network's mobilizations in Ohio and to support their records requests on related voter removals in **all 88 Ohio counties** to support their election protection efforts.
- We provided key support and technical review of a voter challenges guide in Wisconsin authored by All Voting is Local and the Brennan Center.

#### Notices to State Officials Regarding Retention of Election-Related Documents

American Oversight, joined by ten national and state-level partners, including All Voting is Local, Common Cause, Fair Fight, and the League of Women Voters, sent notices to officials responsible for ensuring free and fair elections in **Georgia**, **Arizona**, **Pennsylvania**, and **Wisconsin**, urging them to preserve election-related documents amid growing concerns over election accountability. This effort aimed to assist partners seeking to litigate election subversion issues, ensuring that critical evidence remained intact for future legal challenges and oversight efforts.



#### **Threats to Democracy Tracker**

In 2024, American Oversight developed the <u>Threats to Democracy Tracker</u>, a comprehensive, interactive resource designed to support national, state, and local organizations across the country countering election subversion during the 2024 election. This streamlined tool, informed by partner conversations and extensive research, is bolstered by background tracking on more than 1,822 individuals, 150 organizations, and 246 sheriffs involved in the election denial movement and highlights the actors, funders, and tactics that underpin it.

The tracker offers key insights about the movement's efforts at the national, state, and local levels, with a focus on hotspots like Arizona, Georgia, Michigan, and Wisconsin. Drawing from thousands of documents obtained by American Oversight, the tracker provides advocacy groups with targeted intelligence, empowering them to monitor external influences on election administration, hold election deniers accountable, and safeguard free and fair elections. With additional support, we will update the tracker to include those who are leading efforts to attack civil rights, immigrants, and democratic institutions, including public education, as well as those with anti-democratic connections to the Trump administration.

#### **Anti-Democracy Playbook**

Before the election, American Oversight published the <u>2024 Anti-Democracy Playbook</u>, a comprehensive analysis of eight tactics used by anti-democracy activists to suppress votes and undermine trust in elections. The Playbook outlines how mass voter-registration challenges, politically motivated litigation, dissemination of anti-immigrant conspiracy theories, voter intimidation, partisan election administration, certification delays, pushes for hand counts, and state voter fraud investigations are feeding the election denial movement and threatening our democracy. **Drawing on thousands of pages of public records, the Playbook exposed the network driving these tactics and provided critical insight for democracy protection ahead of the 2024 election.** We will continue to update the Playbook as we uncover more information through public records requests.



#### Far-Right Attacks on Immigrant Communities and Voting

The myth of "non-citizen voting" gained national attention in 2024 as election deniers advanced false, xenophobic claims of widespread illegally inflated voter rolls, pressuring officials to take extreme measures against this nonexistent problem. Rooted in a long history of using anti-immigrant sentiment for electoral gain, the false narrative reflected broader white nationalist ideas such as the Great Replacement theory, which frame immigrants as an existential threat. American Oversight worked with key partners to demonstrate how voting rights were targeted by the weaponization of this myth — a myth that, if aided by Congress this session, will advance a key part of the Trump administration's agenda to make it harder for eligible voters to exercise their right.

- In Arizona, we supported the Arizona Democracy Defense Coalition, working closely with grassroots groups and voting rights experts to file rapid response requests regarding proof of citizenship requirements that threatened to disenfranchise tens of thousands of voters across the state, particularly impacting communities of color, students, and immigrants.
- In North Carolina, our work was cited in letters from voting rights and civil rights advocacy organizations, including the ACLU of North Carolina, Common Cause NC, Democracy NC, Forward Justice, Southern Coalition for Social Justice, and others, seeking to fight politicized attacks on immigrant voters by the Election Integrity Network at polling locations across the state.
- In Texas, we joined multiple letters with grassroots, civil rights, and voting rights groups, including the ACLU of Texas, Campaign Legal Center, Lawyers' Committee, Texas Civil Rights Project, and others, working to combat anti-immigrant rhetoric aimed at chilling Latinx votes. Records we obtained were cited in a letter to the <u>Department of Justice urging compliance with</u> federal law regarding ballot secrecy in Texas election administration, a letter responding to Attorney General Paxton's investigation of voter-registration efforts, and an NVRA notice to the <u>Texas Secretary of State</u> regarding voter purges.
- We hosted a webinar with partners from America's Voice, the Campaign Legal Center, and North Carolina Asian Americans Together to provide resources for responding to allegations of mass voter fraud tied to "non-citizen voting." The panel discussion brought in more than 70 attendees, including election administrators, and explored how anti-immigration rhetoric has been weaponized by far-right groups seeking to sow distrust in voting ahead of the 2024 election.



# Threats to Civil Rights and Liberties

#### **Fighting to Protect LGBTQ+ Rights**

We worked closely with key partners dedicated to protecting LGBTQ+ civil rights, including the ACLU and affiliates and Lambda Legal, to understand the threats facing the LGBTQ+ community and the latest developments in states across the country.

#### Understanding Anti-Trans Policies in Texas' Katy Independent School District

We partnered with the ACLU of Texas on records requests related to parental notification and forced outing policies that would impact students and student organizations in Texas. We recovered records demonstrating that since December 2023, there had been 23 instances of parental notification under the forced outing policy of the Katy Independent School District. The production contained copies of the district's parent/guardian request form for preferred student name changes, student welfare support plans for gender identity, and parental notification forms — documents that are informing the ACLU of Texas' and Lambda Legal's advocacy strategies and understanding of the mechanisms underlying parental notification requirements.

#### Records Bolstering Discovery Motion in Missouri Lambda Legal Case

Lambda Legal is currently fighting Missouri's ban on medically necessary treatments and procedures for transgender adolescents or individuals insured through Missouri's Medicaid program. We obtained records that Missouri improperly failed to disclose in the litigation, which Lambda subsequently cited in its motion to compel discovery.



#### **Fighting to Protect Public Education**

In 2024, American Oversight launched an investigation into the anti-democratic forces attacking public education across multiple states, including Florida, Iowa, Oklahoma, North Carolina, Virginia, and others. American Oversight obtained and analyzed thousands of pages of public records to shed light on efforts to politicize, censor, and dismantle public education, from early elementary school through higher education. Our investigation has revealed the extent of the far-right influences across the nation, culminating in our 2025 report, "The Far-Right Attack on Public Education." With Donald Trump back in the White House, restrictive state-level policies outlined in our investigation are already making their way into the federal government.



- In Oklahoma, we unearthed records of communications reported on by the <u>New York Times</u>
   <u>Magazine</u> that shed light on Oklahoma State Superintendent Ryan Walters' efforts to
   enshrine Christianity in the state's public school curriculum. The records were also used to
   support advocacy initiatives led by the ACLU, American Atheists, Americans United for the
   Separation of Church and State, and Appleseed.
- According to records we obtained, the Virginia Department of Education proposed dozens of
  revisions to the state's African American elective history course curriculum including
  recommendations to remove references to racism and white supremacy. Multiple news outlets,
  including the <u>Washington Post</u>, covered the records.
- Records we obtained from North Carolina demonstrated the confusion among educators about
  what they could and could not say after the state passed a law barring "instruction on gender
  identity, sexual activity, or sexuality" in younger grades. This information has helped inform the
  on-the-ground advocacy of key partners, including the ACLU of North Carolina and the
  Education Justice Alliance.

#### **Providing Transparency in Border Enforcement and Defending Immigrant Rights**

Over the years, American Oversight's work on border and immigration issues has garnered substantial interest from the press, congressional investigators, advocacy organizations, and other key audiences. We've uncovered documents corroborating the account of family members who lost a loved one in immigration custody, exposing Trump administration efforts to rig asylum interviews, exposing the costs of Texas Gov. Greg Abbott's border deployments, and contributing to long-term accountability work around anti-democratic actors pushing xenophobic conspiracy theories and anti-immigrant policies.

#### Shining a Light on Deaths in ICE Custody with the ACLU and Physicians for Human Rights

In collaboration with the ACLU and Physicians for Human Rights, we contributed to the publication of "Deadly Failures: Preventable Deaths in U.S. Immigration Detention," the most comprehensive analysis to date of immigrant deaths in ICE custody. The report, based on over 14,000 pages of documents that we obtained through FOIA requests, state public record requests, and years of litigation, revealed that 95% of deaths could likely have been prevented with adequate medical care. The findings, which detailed egregious practices in ICE detention facilities, generated significant national media attention, and prompted a Senate investigation into medical and mental health care for people in ICE custody. The records also supported wrongful death litigation brought on behalf of surviving family members, demonstrating the critical role public records play in advancing accountability, informing advocacy, and supporting systemic reform. In 2025, our report was prominently featured in HBO's "Last Week Tonight With John Oliver."



#### Providing Increased Capacity to Immigrants Rights Organizations

- Building on our success in exposing costly and flawed state-led border enforcement initiatives,
   American Oversight collaborated with immigrant advocates and partners to advance public
   records investigations. Our legal, research, and partnerships teams presented to the national
   Operation Lone Star Coalition on using public records requests as a tool for accountability in
   immigration policy. Following this presentation, we hosted a meeting with interested partners,
   including Human Rights Watch and the Immigrant Legal Resource Center, to gather new ideas
   for investigations and requests. We also provided tailored support to partners like the Texas
   Civil Rights Project, helping refine their requests and navigate agency responses.
- As a participant in Democracy 2025's Border & Immigration cohort, convened by Democracy Forward, we regularly share our expertise on border enforcement policies (including Title 42, Migrant Protection Protocols, and Operation Lone Star), immigration detention, and the intersection of extremism and anti-democracy actors. Our work is supported by collaborations with leading organizations such as the ACLU, Physicians for Human Rights, and the Texas Civil Rights Project, and through participation in coalitions like the Anti-Hate in the Immigration Debate Coalition and the Immigration FOIA Coordination group. These efforts underscore our commitment to advancing transparency, accountability, and driving systemic reform in immigration and border policies.
- For the third year in a row, American Oversight supported the American Immigration Council and MuckRock during a national convening on immigration and transparency that brought together more than 100 attendees from national, state, and local organizations and media outlets. The convening is a key opportunity for the requester community to discuss transparency challenges across multiple federal agencies, including DHS, ICE, and CBP.



#### **Fighting for Reproductive Rights**

Since the Supreme Court's 2022 Dobbs decision, American Oversight has investigated state funding for anti-abortion centers called "crisis pregnancy centers." These centers, which frequently misrepresent themselves as medical facilities, have received more than \$250 million in taxpayer funding across 12 states where abortion access has been restricted or banned, with significant increases in states like Florida and Tennessee. Many are affiliated with right-wing organizations that promote anti-abortion legislation and have engaged in questionable financial practices, including the misuse of federal funds.

Through public records requests in 15 states, American Oversight has sought to uncover contracts, communications, and financial records to shed light on these practices. We've shared our findings with advocacy partners and reporters, and <u>published backgrounders</u> detailing our findings and <u>exposing</u> threats to reproductive rights.

In 2024, American Oversight <u>launched an investigation</u> into efforts by public officials and conservative groups to curtail reproductive rights by attacking and undermining citizen-led ballot measures. Records obtained by American Oversight from officials in Ohio and Missouri revealed conversations among lawmakers and officials about strategies for circumventing attempts to enshrine abortion rights in state constitutions. By exposing these discussions, American Oversight's work helped inform advocates and the public about the coordinated attempts to subvert democracy and restrict reproductive rights.



### Abuses of Power

American Oversight's mission is to protect democracy by confronting abuses of executive power that erode public trust, empower extremist agendas, and evade accountability. In 2024, our research focused on uncovering patterns of abuse, particularly among those advancing anti-democratic agendas, while our legal team leveraged innovative public records strategies to expose and prevent governmental overreach.

#### Following Lawsuit, Gaetz Withdraws from AG Consideration

President-elect Trump's announcement that he would nominate Rep. Matt Gaetz to lead the U.S. Justice Department sparked significant backlash, in large part because of serious criminal allegations regarding his past conduct, including allegations of sex trafficking of a minor. In November, we sued the FBI for records from the agency's investigation into allegations against Gaetz. Shortly thereafter, Gaetz withdrew his name from consideration.





#### Fighting for the Rule of Law and the Ability to Hold Presidents Accountable

In late December 2023, we filed an <u>amicus brief</u> in Trump's appeal of an earlier ruling holding that he was not immune from prosecution in his federal election interference case. Our brief <u>presented the compelling argument</u> that the D.C. Circuit Court did not have jurisdiction to hear the appeal — and if accepted, would have sent the case back to the trial court — and was the first matter considered and cited by the court during oral argument in January. While the appellate court found Trump did not have immunity from criminal prosecution, the Supreme Court partially agreed with Trump's claims, effectively granting him immunity by further delaying the case. The case was dropped after Trump won re-election.

#### **Holding Michael Gableman Accountable**

In November, the Wisconsin Office of Lawyer Regulation <u>filed a disciplinary complaint against Michael Gableman</u>, the former state Supreme Court justice who led the Wisconsin Assembly's partisan and baseless inquiry into the 2020 presidential election. The complaint outlines Gableman's outrageous misconduct and his failures to comply with state public records laws during the course of American Oversight's litigation, which thoroughly discredited the audit. In 2025, American Oversight received the Wisconsin Freedom of Information Council's <u>Citizen Openness Advocate award</u> for our work prying records from the inquiry.


#### **Exposing the Far-Right Constitutional Sheriffs Movement**

We continued to investigate the far-right constitutional sheriffs movement — the movement based on a fringe theory that sheriffs have more law enforcement power in their home counties than any other government body or individual — and its followers' close connections with prominent election deniers. In addition to our litigation against Pinal County Sheriff Mark Lamb, which led to the release of relevant records and a favorable settlement, we also continued to uncover records from Sheriff Dar Leaf in Michigan, who frequently communicated with anti-democracy activists. Ahead of the 2024 election, we partnered with organizations monitoring sheriffs likely to support election subversion or election denial activities, and shared our records with key grassroots organizations leading election protection efforts on the ground.

#### **Investigating the Arlington National Cemetery Incident**

American Oversight's work to uncover the truth behind an alleged August incident involving the Trump campaign at Arlington National Cemetery exemplifies our commitment to transparency and accountability. Following reports campaign staff had violated federal law by attempting to film in a section of the cemetery reserved for recent U.S. casualties, we requested the Army's report on the incident, ultimately suing and seeking expedited release of the records.

A judge granted our request, recognizing the compelling public interest ahead of the election. The released report, though heavily redacted, confirmed the existence of an ongoing federal law enforcement investigation and documented a physical confrontation classified as simple assault. The alleged incident reflected Trump's broader patterns of politicizing the military and violating ethical boundaries. American Oversight is continuing to pursue unredacted information to ensure the public learns the full story.



# Erosion of Government Transparency

#### Fighting in Court to Affirm the Public's Right to Government Records

In 2024, American Oversight took legal action in states across the country where officials were undermining access to public records.

- We sued Florida Gov. Ron DeSantis' office for its pattern or practice of unlawfully delaying the release of public records, after several requests for communications and calendars went unanswered.
- American Oversight continued long-running litigation against Texas Gov. Greg Abbott and
  Attorney General Ken Paxton, seeking communications with pro-gun advocacy groups and
  communications from the days surrounding the Jan. 6 insurrection, when Paxton spoke at the
  "Stop the Steal" rally. The case is now before the Texas Supreme Court, which is considering the
  government's dangerous argument that the court has no role in ensuring the governor's
  compliance with the Texas Public Information Act.
- In May, a federal appeals court ruled in favor of American Oversight in our 2017 lawsuit seeking communications between **Trump administration officials** and members of Congress or staff about efforts to repeal the Affordable Care Act. The ruling made clear that government agencies cannot use the "consultant corollary" doctrine to evade public disclosure when the supposed consultants have their own interests in the outcome of agency decisions. Although the Department of Health and Human Services and the Office of Management and Budget agree that the remaining records must be produced, the House Committee on Ways and Means continues to delay the case.



#### **Deputy Executive Director Appointed to FOIA Advisory Committee**

In August, the Archivist of the United States <u>appointed</u> American Oversight Deputy Executive Director Liz Hempowicz to the National Archives and Records Administration's 2024–2026 FOIA Advisory Committee. This marks the first time American Oversight has held a seat on this key committee, which advises on improvements to the FOIA process. Hempowicz's appointment highlights our deep commitment to advancing accountability and access to public information, ensuring the requester community's voice is represented at the highest levels.



## Congressional Engagement

#### **Exposing the Network Behind Project 2025**

American Oversight's public records request to George Mason University uncovered emails revealing potential connections between faculty and Project 2025. The findings, <u>highlighted by then-House Oversight Committee Ranking Member Jamie Raskin</u> during a hearing in September, underscored Project 2025's close ties to conservative academic circles, and the investigation provided critical insight into how powerful far-right political agendas have been developed and advanced.

#### Congressional Inspiration from Ranking Member Jamie Raskin
